## INFORMATION DOCUMENT FOR A PERMIT TO POSSESS ENDANGERED FLORA

**I, the owner, hereby declare that I take note of and understand:**

- That the onus is on me to acquaint myself with all legislation pertaining to the buying / selling / donation / receiving as a donation / transport, cultivation and possession of endangered flora.
- That the onus is on me to verify the current conservation status of any flora species that is in my possession or are to be acquired prior to such acquisition on the SANBI Red List of South African Plants at <http://redlist.sanbi.org/> and/or <http://www.iucnredlist.org/> and/or <https://www.cites.org/eng/app/appendices.php>.
- That the onus is on me to acquaint myself with all legislation pertaining to the international trade (import / export) in endangered flora and that additional permits (e.g. CITES and/or Department of Agriculture) may be required.
- That I can apply for permits at my nearest CapeNature regional office.
- That I must have the necessary permit in my possession prior to commencing any activity with any specimen of endangered flora.
- That it is an offence to commence any activity with endangered flora without being in possession of a valid permit authorising that particular activity.
- That any permit has an expiry date and that the onus is on me to apply for the renewal of any permits at least sixty (60) days prior to the expiration.
- That a possession permit does not authorise me to collect any endangered flora or the seed thereof from the veld.
- That a possession permit does not authorise me to trade in endangered flora or the seed thereof or to transport it.
- That I can be held responsible for reimbursement of the costs incurred by CapeNature to conduct an inspection if the minimum requirements for a permit / license are not met.
- That, in the case of repeated offences or failure to comply with permit conditions, it may lead to the cancellation of permits / licenses and/or the withholding of future permits / licenses.
- That, in the case of an offence regarding the specimen(s) contained in this application, the specimen(s) may be confiscated / seized by CapeNature.
