NOTICE OF INTENTION TO DECLARE AREAS AS PART OF THE EXISTING
KNERSVLAKTE NATURE RESERVE

The Provincial Minister of Local Government, Environmental Affairs and Development Planning in the Western Cape (the Provincial Minister)—

- (a) in terms of section 33(1)(a) of the National Environmental Management: Protected Areas Act, 2003 (Act 57 of 2003) (the Act), gives notice of his intention to declare under section 23(1)(a)(ii) of the Act, the following areas (the intended additional areas) as part of the existing Knersvlakte Nature Reserve (the existing nature reserve):
- (i) Remainder of the Farm Zandkraal B No. 217, situated in the Matzikama Municipality, Division of Vanrhynsdorp, Western Cape Province; in extent: 3341, 5545 (Three Thousand Three Hundred and Forty-One comma Five Five Four Five) hectares; held by Deed of Transfer No. T36313/2020;

the boundaries of which are reflected on the map set out in the Schedule;

- (b) notifies that the existing nature reserve and the intended additional areas are situated in the northwest corner of the Western Cape Province, approximately 26 km southeast of Nuwerus, as indicated on the map in the Schedule;
- (c) notifies that CapeNature assessed the intended additional areas, and it is apparent from this assessment that the intended additional areas contain several features that make them eligible for declaration as part of an existing nature reserve;
- (d) notifies that the intended action referred to in paragraph (a) meets the requirements of section 23(2)(b)(i), (ii) and (iii) of the Act, as it is aimed at protecting the intended additional

areas, which have significant natural features or biodiversity; are of scientific, cultural, historical or archaeological interest; and are in need of long-term protection for the maintenance of their biodiversity or for the provision of environmental goods and services;

- (f) notifies that the Provincial Minister is not, at this stage, aware of any potential rights or interests of the local community, or stakeholders other than the owner of the existing nature reserve and the intended additional areas, that may be affected by the intended actions referred to in paragraph (a);
- (g) invites members of the public to submit to the Provincial Minister written representations on or objections to the intended action referred to in paragraph (a) within 60 days from the date of publication of this notice in the *Provincial Gazette* by—
